It will be primarily used as a decorative window film to create an etched (engraved) effect on windows or glass panels in architectural enhancement and advertising/display installations in locations such as retail environments and lifestyle business environments (bars, hotels, restaurants, casinos, theatres, etc). It will also be used for glass conspicuity for personal safety in locations with high footfall, such as shopping centres and educational establishments. The specially-formulated, flexible film has consistent matt levels and it delivers a high degree of dimensional stability and colourfastness and it can be cut easily and weeded quickly and the high-quality, PE-coated liner further promotes excellent layflat, cutting and weeding characteristics. The permanent, solvent-based adhesive creates a strong final bond to ensure a secure and durable finish. It incorporates PerfectApply technology to increase repositionability during installation and to facilitate a bubble-free finish, especially in the case of large, flat-panel installations. In relation to ImagePerfect<sup>TM</sup> Satin Crystal, this HD option is denser, allowing for a different aesthetic finish and lending itself better to privacy screening installations. For digital conversion, it is compatible with eco solvent, solvent, latex and UV-cured inks, to which end it will deliver high levels of print quality with remarkable text definition and a large colour gamut, ensuring colourful images with high black values and vibrant area in-fills. Laminate: IP 2810-200. In order to retain the crystal look of the product, it is important that this match-component crystal laminate is used (and not a standard gloss or matt laminate). In order to ensure the best results, this product must be dry applied. In application, the film will absorb just 5.5% of visible light / transmit 94.5% of visible light.
